  - The name listed on the "*Shareholder Applicant Name*" line will be the name listed on the Stock Registry of Stonycroft Hills Club, thus making this individual the sole owner of the stock in Stonycroft Hills Club.
  - Only the Shareholder is eligible to vote on issues presented to the Shareholders by the Board of Directors.
  - The name of the Shareholder will be listed in the Roster, with the Spouse or Significant Other's Name in parentheses [i.e., Doe, John (Jane), Doe, Jane (John)]. The Shareholder and Spouse/Significant Other will have their own record on the website, providing individual phone numbers and email addresses.
  - The Shareholder, Spouse or Significant Other, and related Members (as set forth in the Bylaws and Rules) shall comply with all requirements of Stonycroft Hills Club.

### **Junior Membership (Amortized Equity Ownership)**

Individuals under 40 years of age (and over 18 years of age) at the time of application can earn a full (non-discounted) equity membership over a three-year period. Once they become a full equity member voting privileges are earned.

Initiation Fee of \$12,500 is paid over 3 years:

- \$5000 1<sup>st</sup> Year (minus application fee and waiting list fee, if applicable)
- \$4000 2<sup>nd</sup> Year
- \$3500 3<sup>rd</sup> Year

There is a \$560 Security Deposit due upon Membership Acceptance which is credited after the full payment of Initiation Fee.

All dues and fees will be charged which allows full golf membership privileges.
